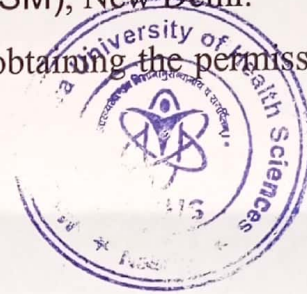


- 4) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.
